BEING A CONTRIBUTOR

I'm fascinated with people that can take a 2000 to 3000 piece puzzle out of the box and have the patience and ability to put it together. I often wonder how difficult would it be to put the puzzle together if half the pieces were missing.

I have realized that what we do with the residents' lives is not that much different; it takes patience and the ability to help them put their lives back together.

When we interact with residents, each interaction leaves a piece of them with us. These interactions can be seen as puzzle pieces of their lives. A single interaction alone has very little meaning; however, you see the full picture when they all come together.

Many times these pieces of interaction may seem very small, unimportant, thus they go unreported. Exchanges such as:



Each piece of interaction that's recorded in the computer log, on a behavior report, or in the case file will go a long way in getting the full picture and assisting in the treatment process.

When we put all the above pieces of interactions together, we can see that this resident's thoughts and emotions are barriers to his/her treatment and need to be addressed.

Conversely, each piece that's kept and goes unrecorded will make it impossible to get the full picture.

You must ask yourself this question "am I a hoarder, keeping all my resident interactions and conversations for myself, or am I a team player sharing my interactions and contributing to the residents' treatment process?"

I will leave you with three words; sharing is caring!

HEATHER REJOINS THE TEAM AS THE HEAD OF COMMISSARY!

On November 30, 2020, Heather Duke was rehired to fill the Commissary Coordinator's role. Heather previously worked as a case manager; however, due to programmatic cut-backs necessitated by the COVID-19 pandemic, her position was abolished, and she was laid off on June 30, 2020. Once the decision was made to develop a commissary program that would provide food, personal hygiene items, leisure activity materials, and other items residents can purchase, it was necessary to find a coordinator.

Understanding the need to fill the coordinator's position with a detail oriented, organized, multi-tasker who had a working knowledge of NEOCAP's treatment environment, the Management Team quickly decided to reach out to Heather for this role. A telephone call to Heather started the "ball rolling," and Heather rejoined the team before you knew it. On December 23, 2020, the first orders of Commissary were delivered to NEOCAP's male and female facilities.

On February 8, 2021, Heather made the following comments: "I was overjoyed when Kim called and asked to speak with me about a new position. I loved working for NEOCAP and took great pride in being a part of the team, so I was honored to be considered for the Commissary Coordinator's role. Being considered to help start a program from the ground up made me feel valued, and it showed me that Management did take notice of my work ethic and dedication in the past."

FORMER RESIDENT EXPRESSES WORDS OF GRATITUDE AND APPRECIATION

On February 5, 2021, former resident Sally Filipcic contacted the facility to express her gratitude and appreciation for all the help she received from the NEO-CAP staff and program. Ms. Filipcic stated:

"I entered your Painesville facility in January 2019 and since being released, I have maintained my sobriety (25 months), got custody of my granddaughter and daughter, paid off all my fines, and graduated Mental Health Court and Probation successfully."

Ms. Filipcic explained that coming to NEOCAP saved her life, as she was suffering from Congestive Heart Failure and using drugs, which would have undoubtedly led to a heart attack and death. She is very proud of her relationship with her four children, who have also struggled with drug abuse and addiction. According to Ms. Filipcic, "When I got out, I told them I love them, but until they're right, they need to stay away from me. To my surprise, all four immediately got sober and stayed sober to this day (18 months), to support themselves and me, our relationship is AWESOME."

Ms. Filipcic went on to say that "I enjoy the freedom of sobriety, spending all my money and time on my granddaughter, other children, and my animals—even cleaning house is enjoyable sober. I'm grateful to have a happy, safe, sober home to clean."

When asked, how exactly did NEOCAP help you, she responded: "NEOCAP helped me by teaching me what healthy boundaries were and how to use them, thinking of scenarios before a situation and how to handle them maturely, controlling my anger. Since my release I have had some hardships like I lost my mom, two of my animals passed, son went to prison, three close friends died from relapsing, financial problems, etc, but I didn't run to any substances through it. I feel, deal, and heal! I use and apply skills I have learned at NEOCAP each and every day and because I do I'm sober, happier, and completely legal, no more court, fines, probation, how awesome is that?"

Ms. Filipcic summed up her gratitude and appreciation in the following manner: "I now enjoy my life thanks to your staff and program. Please let all the staff know that they saved not only one (1) life, but five (5) - Thank You!!!"

Over the past few months, the Maintenance Department worked with local vendors to obtain special protective shatter-proof glass and construct a wall around the Male Facility Lower Level Staff Post.

NEOCAP had previously received grant funds from OCJS Coronavirus Emergency Supplemental Grant to erect permanent glass protective barriers at the male facility's Unit 1 and Unit 2 main staff posts.

NEOCAP STAFF RECEIVE COVID-19 VACCINE AT PACKARD MUSIC HALL



On January 27, 2021, the Warren City Health District held a Coronavirus Vaccination Tier 1A clinic at Packard Music Hall. Twenty-five NEOCAP staff, along with hundreds of others, stood in long lines and endured temperatures in the 20s to take their first of two Moderna Vaccine shots. Below are various staff reactions to their experiences with the vaccine process.

Administrative Secretary Cheryl Moran expressed, "I wasn't nervous about getting the shot, no different than the flu or pneumonia vaccine. My arm was sore and I was tired for a day or two afterward. It was a bit cold waiting outside in line, but once inside the warm building, the process was well organized; masks and social distancing were enforced and the line moved quickly. I am thankful to have had the opportunity to receive the vaccine to help safeguard my family and friends."

Ben DeGennaro Treatment Specialist shared, "Before I got the shot, I was just excited that things can finally get back to normal. I haven't seen my parents since Thanksgiving because they are petrified that they will get sick and die. Me getting the vaccine will make them more comfortable.

During the shot, I was very cold from waiting in line. I thought the process could have been more efficient. Also, I was determined to get it done so that I can finally have an excuse to go places by saying 'I'm able to go because I got the vaccine!!! The reason for that is because I have really not been out of the area since June of 2019, which is a long time for my family because we like to travel.

After, I was a little sore in the arm, but that's about it. I appreciated NEOCAP for allowing me to get the vaccine so early. Can't wait for the second one!"

Compliance Manager Brenda Waters commented, "Before taking the vaccine, I was very skeptical about the vaccine, so I called upon my niece, a neuroscientist who tests and develops new medications. She said she was skeptical at first, but assured me that after much reading and research, it was safe, and she was taking it. She helped convince me to get the vaccine. Besides standing in the cold for 45 minutes to get the vaccine, my experience getting it was good. I did have a tender arm for a day and was a bit tired. I am looking forward to getting my second dose. I'm hopeful that in the next six (6) months to a year, we can again enjoy the freedoms and the people we all love the way we always have.

As told by Lisa Rowe Operations Director, "When I heard a vaccine would become available, I wondered if it is in my best interest to get it and decided to find out what information I could about the vaccine before making a decision. Once I did as much fact-finding as possible, I decided that I would want to get the vaccine. I had heard some individuals experienced side effects, but decided that those would be much better than actually contracting COVID, which could put the health of anyone that I came in contact with in jeopardy. Signing up for the vaccine was much easier than I expected! The morning of the vaccine, wow, the line was long, but I was thankful I got to chat with a couple of coworkers that were in line with me and made the time go by faster. Then it was time, and the shot did not hurt at all!!! The only symptom I experienced from the first dose was being tired that evening, and I felt like someone hit me in the arm with a baseball bat for three days. I was not sick at all. I have very few concerns about receiving the second dose. Even if I get symptoms, I know it is not the live virus and will be temporary."


