#### MENTAL HEALTH STARTS WITH REALISTIC EXPECTATIONS!

I know at times it feels like nobody knows or cares about the stress and burnout related to working in correctional treatment. Over my 30+ years of working with the offender population, I have found that the best way to maintain a healthy mental mindset is to have realistic behavioral expectations for the people we serve. Remaining mindful that our clients' traits of selfishness, lying, manipulation, blaming others, etc., existed long before they arrived on our doorstep, and they will not magically disappear.

Understand that change is not only difficult; it's a process that takes time and commitment. A lying manipulator on a Monday before entering the program will still be a liar and manipulator when joining the program on Tuesday. No one should be surprised or upset when they engage in such behaviors.



Working in this field is NOT the right job for the individual who wants to "fix people" or have joyful, memorable "Kodak Moments" with their clientele.

Some of our younger staff might wonder, "what the heck is a Kodak moment." Before the invention of cell phone camera technology, the Kodak camera was how we "oldheads" recorded our joyful moments and memories.

We must be aware that helping offenders change their criminogenic behaviors is a painstaking process filled with trials and tribulations and very few, if any, Kodak moments.

Realistic Expectations = Less Stress = Less burnout !!!

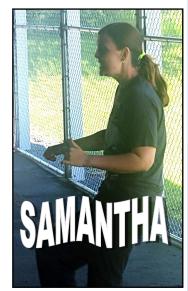

#### THE WARREN AND PAINESVILLE FACILITIES UNDERGO STATE PROGRAM AUDIT!

Auditors from the Bureau of Community Sanctions (BCS), a division of the Ohio Department of Rehabilitation and Corrections (ODRC), conducted its bi-annual pro-



gram audit on March 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup>, 2021. The first two days of the audit were performed off-site via electronic auditing of the majority of the agency's standards, policies, and procedures. On day three, BCS auditors James Dowdell and Karl Blissenback conducted a full-day program review at the Warren facility that included reviewing case files, conducting a facility inspection, and interviewing staff and residents. BCS auditor Shannon Woehrman provided the on-site auditing activities at the Painesville facility.

BCS is completing the final report; however, all three auditors express high ratings and praise for both facilities.

Here is the feedback provided by Ms. Woehrman during the facility inspection, case file review, and resident interviews. (1) The facility is spotless and in good order, well maintained (2) The case plans were excellent and comprehensive (3) The residents knew what programming they were in and why (4) There was consistent quality in the term reports across Case Manager (5) She was impressed by our CCIS accuracy. Now we await the Final Report!

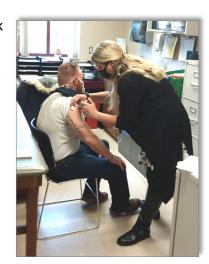
On April 19, 2021, Lindsey Adams and Teresa Merrick from the Trumbull County Health Department provided COVID 19 vaccines to interested staff and residents.

The vaccine clinic went well. 28 residents and 3 staff (along with one family member of staff) received the Pfizer vaccine.

Staff worked well together to make this a smooth operation and the representatives from the health department mentioned they could not believe how smoothly it went. They started a few minutes after 9 a.m. and were finished by 9:40 a.m.

The health department returned on May 10th and provided the 2nd dose of the vaccine. Residents who

were released before that date, or who were unable to attend that clinic, worked with their case manager to get scheduled in the community for their second dose.



#### COVID VACCINE CLINIC AT THE NEOCAP FEMALE FACILITY

On April 13, 2021, at 2:00 p.m. nursing staff LeAndre East and Brittany Rowan from the Lake County General Health District came to the Female Facility for our first COVID-19 vaccination clinic. During the clinic 24 people were able to receive dose #1 of the Pfizer vaccine. These 24 people consisted of 20 female residents, 2 staff members, 2 staff family members.

The clinic ran smoothly, with all 24 vaccinations administered in less than an hour. Nursing staff from the Lake County General Health District returned to the Female Facility on May 11, 2021, and administered the second dose of the vaccine to those who participated in the first vaccine clinic.



We would like to express our gratitude to the Lake County General Health District for taking the time to come to the facility to provide vaccination services.



#### Warren Facility— Flooring Resurfacing Project

During the two weeks of March 13-22, 2021, several Warren facility floors were removed and replaced with the highest scratch-resistant vinyl tile. With the resurfacing of the dining hall, sally port, and the lower expansion wing, the facility moved closer to having all of the original floors, which are 25+ years old, replaced. Although the two-week floor project was disruptive to the daily operations of the treatment program, the new flooring adds a quality of class, warmth, and comfort to the facility. According to Executive Director, Jake Jones, "the goal is to replace all the original flooring, eventually. However, due to budgetary constraints and the need to seek additional State capital improvement funds, it will probably be three to four years before the goal will be met."

#### COVID-19 PROTOCOL REDUCTIONS

With the recent Center for Disease Control and Prevention (CDC), Governor Mike DeWine, and the Ohio Department of Health (ODH) decisions to lift COVID-19 restrictions, NEOCAP has started the process of returning back to pre-COVID operations.

- 1. Effective June 2, 2021
  - Mask wearing will be optional for staff and residents.
  - No temperatures required for staff when entering the facility.
- 2. Effective June 6, 2021
  - Visitation will begin for only fully vaccinated residents.
  - Visitor orientation restarting.
  - No temperatures required for visitors entering the building for visitation.
- 3. Effective June 7, 2021
  - Lobbies reopened to the public—no temperatures required.
  - Property drop-off, during business hours only, in the main lobby.
  - Probation reporting restarting—no temperatures required.

Over the next several months, Management will continue to monitor the COVID-19 recovery and continue to remove restrictions with the goal of returning to "normal" operations in the near future.

## Winning Recipe . . . .

#### SPINACH ARTICHOKE SPAGHETTI SQUASH BOATS WITH CHICKEN — Submitted by: Samantha Works



#### **INGREDIENTS:**

Spaghetti Squash_	<u>Chicken</u>
1 large spaghetti squash, cut in half, seeds removed	1 lb. chicken cubed
2 tbsp olive oil	2 tbsp olive oil
½ tsp salt	3/4 tsp salt
¼ tsp pepper	¼ tsp pepper

#### Si

<u>Sauce</u>	
3 cloves garlic, crushed	⅓ cup Greek yogurt
2 tbsp butter or olive oil	$\frac{1}{2}$ -1 tsp salt to taste
2 tbsp cornstarch	1 15 oz. can artichoke hearts, drained and quartered
½ cup milk or almond milk	2 cups fresh spinach, packed
½ cup chicken broth	½-1 cup mozzarella cheese, shredded
3 tbsp cream cheese	Parsley, fresh, optional
1/3 tbsp cream cheese	Parmesan cheese, optional

#### **INSTRUCTIONS:**

#### Spaghetti Squash

- Preheat oven to 425 degrees.
- Cut one large spaghetti squash in half lengthwise. Discard seeds.
- Drizzle 1 tablespoon olive oil in each half of the squash and sprinkle with equal amounts salt and pepper.
- Place face-down on a parchment paper or aluminum foil-lined baking sheet.
- tender and shreds Roast squash in preheated oven for 45-50 minutes, or until squash is easily with a fork.

#### Chicken

- Drizzle 2 tablespoons olive oil in large skillet. Place cubed chicken, salt and pepper, into skillet and cook over medium heat for 6-8 minutes, or until chicken is cooked through.
- Remove chicken and set aside.

#### <u>Sauce</u>

- Once chicken is removed, in the same skillet, place butter and garlic. Sauté for 1-2 minutes or until garlic is golden brown.
- Add cornstarch to the butter and garlic and reduce heat to low. Whisk until a thick paste
- Slowly add milk and chicken broth over the course of 3-5 minutes, stirring constantly.
- Add cream cheese, Greek yogurt and salt to taste. Stir to combine.
- Add artichoke hearts and spinach. Stir to combine and let simmer for 3-5 minutes.
- Add chicken and let heat through for an additional 5 minutes.

#### For the Assembly:

- Once spaghetti squash halves are done baking, remove from oven and shred insides with a fork to form spaghetti "noodles."
- Fill each half with equal parts of the spinach artichoke and chicken mixture, making sure to pull up the noodles so the sauce spreads out evenly.
- Top both halves with equal amounts of mozzarella cheese.
- Set oven to High Broil.
- Broil spaghetti squash halves for 3-5 minutes, or until cheese just starts to bubble and turns a light golden brown.
- Top stuffed spaghetti squash halves with parsley and parmesan cheese. Enjoy!
