AUDIT FINDINGS

Narrative:

I arrived at the facility and was given a tour of the entire facility to includes all resident housing and group rooms. I looked in every room and closet. I observed resident and staff interaction. I observed all the notices of my visit and all signs posted on the zero tolerance for sexual abuse that includes how and who to report an allegation. I questioned staff and residents about PREA and their knowledge of the policies. I called the numbers posted for reporting and also the number for the crisis center. I looked at camera locations and observed the video monitoring in the control center. The monitoring also includes the ability to hear conversations. I reviewed staff files for training and backgrounds. Resident assessments, re-assessments. I read all necessary policies and procedures. I also reviewed the staffing plan and compliance reports. I conducted interviews with both female and male residents, kitchen staff, intake, case managers, PREA coordinator, Deputy Director, security staff , food service and medical staff. The facility was spotless, staff and residents were open and friendly. Everyone I encountered was willing to answer any questions. You could tell they had a healthy culture by observing staff and residents communicate in a professional manner.

AUDIT FINDINGS

Facility Characteristics:

North East Ohio Community Alternative Program (NEOCAP) has been in operation since October 1997. NEOCAP is a regional minimum security residential Community Based Correctional Facility (CBCF) which serves as a sentencing option for adult male and female felony offenders from the Common Pleas Courts of Trumbull, Portage, Lake, Geauga, and Ashtabula Counties. CBCF's were developed by state legislation to provide comprehensive residential treatment for offenders on felony probation, up to a maximum of six (6) months. CBCF's represent the most restrictive community sanction provided by law. CBCF's are a unique partnership between the State Department of Corrections and the local Common Pleas Court Judges. NEOCAP is administered by a Facility Governing Board whose members are appointed by the Judicial Advisory Board and County Commissioners. NEOCAP is separated into a 125 bed facility for males located at 411 Pine Avenue SE, Warren, Ohio and a 60 bed female facility located at 1955 Blasé Nemeth Road, Painesville Township, Ohio. Each facility has ample space for counseling and educational activities.

115.211	Zero tolerance of sexual abuse and sexual harassment; PREA coordinator
	Auditor Overall Determination: Exceeds Standard
	Auditor Discussion
	<p>The written policy outlines a zero tolerance for any incidents of sexual abuse or harassment. The policy outlines the procedures for preventing, detecting and responding to sexual abuse and harassment claims. The policy defines the prohibited behaviors and sanctions for sexual abuse or harassment. The policy outlines strategies to reduce and prevent sexual abuse or harassment. There are signs though out the facility explaining that there is a zero tolerance policy for any incidents of sexual abuse or harassment. There are phone numbers posted by all resident phones indicating the numbers to report abuse or to receive counseling. I interviewed 19 staff and 18 residents and they all have been trained in the zero tolerance policy. Several residents made the statement that "its everywhere".</p>

	The facility does not contract with any outside agency for the housing of residents.

115.213	Supervision and monitoring
	Auditor Overall Determination: Exceeds Standard
	Auditor Discussion
	The Policy clearly outlines that the facility shall develop and document a staffing plan that provides for adequate levels of staffing, and, where needed video monitoring, to protect residents against sexual abuse. The policy outlines the requirement for documenting any deviation from the plan. They do document when someone is off for whatever reason but they always replace the staff so there is no deviation from the plan. I reviewed the staffing plan, camera locations and interviewed the Assistant Facility Director who monitors the staffing patterns and she stated she takes into consideration incidents in determining staff patterns. They keep minutes to their yearly staffing meetings.

	Auditor Discussion
	The Facility does not do cross gender searches of any kind. The policy uploaded did not clearly outline that staff could not strip search transgenders to determine their body parts. After consultation the policy was updated. All staff interviewed state that they do not do cross gender searches of any kind. All residents interviewed stated that the opposite gender staff have never observed them naked and no cross gender staff have ever searched them and always announce their presence.

	Auditor Discussion
	The facility has a MOU with Community Solutions to provide those residents with interpreters for what ever language they speak. Staff are required to help those residents who may not be able to read and understand. The policy does not allow other residents to interpret for any sensitive issues including sexual abuse or harassment. All staff interviewed stated they do not use resident interpreters. The only issue that came up was staff were unsure of who to call for interpretive services but they did know to notify a supervisor if the situation came up. They have not had any resident enter the facility who did not speak English.

NEOCAP reserves the right to have a criminal record check conducted on all contracted persons. NEOCAP prohibits hiring or promoting anyone who may have a documented instance of engaging in sexual abuse or has been convicted of engaging or attempting to engage in sexual abuse. The Business Director or designee will request a LEADS Background Check on all current employees on the employees' birthday each year. They do not wait 5 years. The Business Director will ensure that there are not any new convictions brought forward on the LEADS report. In the event that there is a new conviction that was not reported by the staff member, the Business Director will notify the Executive Director. The Executive Director or designee will investigate the matter. Failure of a staff member to bring this information forward can be grounds for disciplinary actions that may range from suspension up to termination of employment. I reviewed every file of anyone hired in the last 12 months and random files of several staff who have been there at the facility for over one year. All files contained the background information. Backgrounds on staff a run every year on the birthday. </p>

Since the last audit they have updated the camera system. Staff have a clear view from the control centers and supervisor offices. I found no blind spots. The facility has windows in all the doors so that staff walking by can check in offices and closets. This system that they have is one of the best I have seen. You can see every clearly and hear what going on in resident areas. There are no cameras in bathroom areas. </p>

	Auditor Discussion
	The facility policy outlines the comprehensive plan for investigating sexual abuse allegations. The facility has MOU's for investigating, evidence collection and forensic exams. The facility also has an MOU with counseling services. The plan takes into consideration all standards. All staff interviewed understood their role if an incident occurred. Residents interviewed knew if an incident occurred that they would be provided a advocate and counseling services. There have been no incidents in the last 12 months.

	Auditor Discussion
	The policy clearly outlines the responsibilities of the facility, law enforcement, hospital and victim services if an incident occurs, The facility will conduct an administrative investigation to determine the status of those involved. The facility Director will work with law enforcement through out the investigation and criminal proceedings. The facility will keep the resident informed of everything happening on the case.

115.231	Employee training
	Auditor Overall Determination: Exceeds Standard
	Auditor Discussion
	All staff have received PREA training. The Shift Supervisors interviewed could state all the first responder responsibilities for responding to an allegation of sexual abuse. Resident Supervisors are not considered first responders and stated they would call a supervisor. I recommended they create cards for employees that state the procedures for reacting to abuse allegations. The facility created the cards within hours for all employees so any employee would know the proper procedures in case a first responder was unable to respond. I interviewed 19 staff who all stated they have received the training. They understood the responsibilities for prevention, detection, reporting, and response policies and procedures.

115.232	Volunteer and contractor training

	Auditor Discussion
	There was one contracted nurse who stated she had not PREA training since 2007 upon checking she had the training in the last 90 days. I recommend they review the contract for this contractor. I reviewed training records and all staff and contractors have received the training in the last 12 months.

115.233	Resident education
	Auditor Overall Determination: Exceeds Standard
	Auditor Discussion
	I reviewed the policy requiring training for residents. I reviewed records of 15 residents and all had received the training on the zero tolerance for sexual abuse and harassment. I interviewed 18 different residents who all stated they received the training. They all were able to answer the questions for reporting sexual abuse or harassment and what the procedures were for investigating and receiving counseling.

115.234	Specialized training: Investigations
	Auditor Overall Determination: Exceeds Standard
	Auditor Discussion
	The facility does not do criminal investigations, all criminal investigations are referred to law enforcement. The facility will conduct administrative investigations and collaborate with law enforcement to insure all procedures are followed. The facility has 3 staff trained to conduct investigations with one of those staff trained to be a trainer. There have been no allegations of abuse in the last 3 years. I interviewed the investigator and he is aware of his responsibilities and will work with law enforcement to insure their needs are met.

115.235	Specialized training: Medical and mental health care
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	Medical staff are contracted and receive training as required by the standards.

115.241	Screening for risk of victimization and abusiveness
	Auditor Overall Determination: Exceeds Standard
	Auditor Discussion
	The policy outlines the procedure for screening for risk of victimization and abusiveness. All offenders are screened within 48 hours of arrival. During the 18 resident interviews most stated they were assessed with a few hours of arrival. The tool is an objective instrument and follow up reviews are ongoing as long as the resident is at the facility. No one is disciplined for refusing to answer any of the questions. Upon reviewing 15 resident files all documentation was present. When I conducted the interviews with the residents they confirmed being asked the questions on the risk assessment.

115.242	Use of screening information
	Auditor Overall Determination: Exceeds Standard
	Auditor Discussion
	All potential residents are screened using the risk assessment while in the jails awaiting sentencing. This procedure allows the facility to insure proper placement in bed assignments and programs. The residents are assessed upon arrival or with in 72 hours and a follow with in 30 days or when ever any new information comes up. Any resident who is lesbian, gay, bisexual, transgender, or intersex work with staff to determine housing, programing and bathroom needs. The facility had has 2 transgenders who just wanted to be treated like everyone else.

115.251	Resident reporting
	Auditor Overall Determination: Exceeds Standard
	Auditor Discussion
	Policy states that residents can report verbally, in writing, anonymously, and from third parties for any incidents related to sexual harassment or abuse. The facility has a hotline the residents or staff could call to report abuse. There is also a MOU to report to a counseling center and the phone number is by the resident phones. All 18 residents interviewed stated to me the different ways the could report. Most stated they would report to staff. All visitors are given information on the reporting procedures. Signs are placed on the walls through out the facility stating the zero tolerance policy for sexual abuse or harassment.

115.252	Exhaustion of administrative remedies
	Auditor Overall Determination: Exceeds Standard
	Auditor Discussion
	The policy clearly outlines the process for filing a "grievance" or a complaint. There have no grievances filed in the last 3 years. The facility doesn't require the use of the grievance procedures, they just use a report process for residents to report any issues they may have at the facility. The reporting process has no time lines and all complaints must be looked into as soon as possible.

115.253	Resident access to outside confidential support services
	Auditor Overall Determination: Exceeds Standard
	Auditor Discussion
	The facility an established an MOU that provides treatment services. This service is available 24 hours a day. The resident can place a call to them directly or the facility can make contact. The information about the service is posted by the phones with a toll free number. All 18 residents interviewed were aware of the services and knew how to get access.

115.254	Third party reporting
	Auditor Overall Determination: Exceeds Standard
	Auditor Discussion
	All visitors are given information on how to reports any sexual abuse or harassment. There are signs posted though out the facility clearly outlining the zero tolerance policy. All of the residents interviewed knew that any third party could report abuse.

115.261	Staff and agency reporting duties
	Auditor Overall Determination: Exceeds Standard
	Auditor Discussion
	If an allegation of sexual abuse or harassment is brought forward by a resident, third party, staff or the hotline it will be turned over to the facility investigators and law enforcement. All 19 staff interviewed stated they are required to immediately report any information on sexual abuse allegations. All staff knew they were to keep all information confidential. They understood the reports could come from 3rd parties and were to be taken seriously.

	Auditor Discussion
	All staff interviewed stated if they received information that a resident was in imminent danger of sexual abuse that they would take immediate action to keep the resident safe from harm.

115.263	Reporting to other confinement facilities
	Auditor Overall Determination: Exceeds Standard
	Auditor Discussion
	The facility complies with the standard to immediately report an allegation of sexual abuse to the facility the alleged abuse took place. As proof they provided a letter dated in Feb. 2019 where they reported an allegations to another facility.

115.264	Staff first responder duties
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	While interviewing first responders they were able to recite response to an alleged sexual abuse incident. The facility met this standard but I recommend they train all security staff in first responder duties in case the first responder supervisor becomes unavailable.

115.265	Coordinated response
	Auditor Overall Determination: Exceeds Standard
	Auditor Discussion
	The facility has an excellent coordinated response to sexual abuse. I reviewed the training files and all staff have received the training. All staff interviewed understand their responsibilities in the coordinated response. b. First responder actions: Non- Security Staff : Separate the alleged victim and the alleged abuser. Advise the alleged victim to take any action that could destroy evidence. Notify the security staff, Operations Director and Resident Supervisor. Initiate an incident report. First Responders: Separate the alleged victim and the alleged abuser. Preserve and protect the crime scene. Advise the alleged victim not to take any action that could destroy physical evidence. Ensure the alleged abuser does not to take any action that could destroy physical evidence. Work with agencies with MOU's to insure a coordinated response.

	Auditor Discussion
	There is no collective bargaining.

115.267	Agency protection against retaliation
	Auditor Overall Determination: Exceeds Standard
	Auditor Discussion
	All 19 staff interviewed were aware of the policy against retaliation for anyone reporting sexual abuse or harassment. The Deputy Director is responsible for monitoring retaliation. She stated that she monitors the residents and staff on a continual basis to insure there is no retaliation.

	Auditor Overall Determination: Exceeds Standard
	Auditor Discussion
	All criminal investigations are conducted by outside law enforcement. The facility conducts administrative investigations while cooperating with law enforcement so that they don't contaminate the legal process. With the excellent training and camera systems they have not had any allegations of sexual abuse in the last 12 months. The facility has trained investigators.

	Auditor Discussion
	The facility uses a preponderance of evidence criteria in determining punishment for sexual abuse or harassment.

115.273	Reporting to residents

	Auditor Discussion
	The policy and all interviews with the investigators and administrators understand the requirements for keeping the resident notified of all developments in any investigation of sexual abuse.

115.276	Disciplinary sanctions for staff
	Auditor Overall Determination: Exceeds Standard
	Auditor Discussion
	Any employee determined to have engaged in sexual misconduct, retaliation, or conversations or correspondence which suggests a romantic or sexual relationship with a resident will be subject to discipline consistent with the staff code of conduct, up to and including termination. The employee may also be subject to criminal prosecution. Automatic termination will be the presumptive disciplinary sanction for staff who have engaged in sexual abuse.

115.277	Corrective action for contractors and volunteers
	Auditor Overall Determination: Exceeds Standard
	Auditor Discussion
	Any contractor or volunteer who engages in sexual harassment that is not considered criminal activity will be prohibited from returning to the facility and may be prohibited from any other contact with residents such as calling, writing or attending outside community meetings. While the facility cannot dictate that contractors or volunteers not attend outside twelve-step, religious, or community service sites, the facility will not permit a resident to attend the will consider whether to prohibit further contact with residents. Any contractor or volunteer who engages in sexual abuse will be prohibited from returning to the facility and reported to law enforcement, as well as any relevant licensing bodies.

115.278	Disciplinary sanctions for residents
	Auditor Overall Determination: Exceeds Standard
	Auditor Discussion
	The facility prohibits all sexual activity between residents and will discipline residents for such activity. The facility does not, however, deem such activity to constitute sexual abuse if it determines that the activity is not coerced. In substantiated cases of sexual activity between residents, both parties would be subject to discipline up to and termination from the program. Any resident determined by the preponderance of evidence to have attempted or completed sexual abuse will be arrested by law enforcement and transferred to the County Jail. No resident who has had any type of physical contact (i.e. violence or sexual violence) with another resident will be permitted to remain at the facility. There have been no reported incidents.

115.282	Access to emergency medical and mental health services
	Auditor Overall Determination: Exceeds Standard
	Auditor Discussion
	The facility has an MOU with a medical crisis center who responds and is trained to collect physical evidence and then provide all victim services. This service provides medical staff that are trained in the safe/sane protocols.

115.283	Ongoing medical and mental health care for sexual abuse victims and abusers

	Auditor Discussion
	The facility has an MOU to provide medical services for any needs that may occur in the case of sexual abuse.

	The facility conducts a review of all substantiated sexual abuse investigations. During this rating period there were no substantiated cases.

I had access to staff training and employment files.
